Post Card From The Past.

Time, yet again, for the Lake Superior Steelhead Association year in review. The years never seem to pass any slower! This is an incredibly important segment that helps keep our membership up to date with the goings on of the LSSA and the incredibly important work we are doing to rehabilitate our precious fishery as well as the numerous outreach projects and activities that we sponsor. 2017 marks my first year in doing this and brings me incredible pleasure to update all on what has transpired throughout the year.

This year realized the closure of the French River hatchery with the initial proposal to transfer all Kamloops reproduction to Spire Valley hatchery. However, this fall brought a round table from the MN DNR to discuss the first round of findings supplied from the Steelhead Genetics Study. The study found a percentage of fish displaying introgression of Kamloops genes with naturalized fish as well as a small number of naturally reproduced Kamloops. The MN DNR sought recommendations from stakeholders regarding steelhead management options. These options included, maintaining the existing management plan, ceasing all stocking while maintaining no harvest on naturalized steelhead and evaluating harvest options during next management plan revision, a limited steelhead harvest, or utilizing pre-smolt steelhead that are clipped and stocked for harvest. The LSSA realized the threat of impure steelhead genetics and took the stance of maintaining the no harvest on steelhead and supplying a near shore fishery that would not increase current prey competition and mitigate the risk of naturalized steelhead genetics. Our suggestion proposed the stocking of 50,000 Seeforellen and 50,000 Atlantics for evaluation. This is a topic sure to remain a large focus for us moving into 2018.

In the same light, the LSSA was invited to be an advisory member as the WI DNR looks to refresh their 10 year management plan for the Lake Superior waters of Wisconsin. We are answering the call and have participated in several meetings thus far. However, the plan is still in its infancy so please look for further updates in 2018.

Again in 2017, the LSSA continued with the popular Youth Steelhead Mentoring Program. As always, we had a great group of participants! We held informational/teaching sessions Hartley Nature Center. This involved the teaching of various knot tying, rigging up a rod, angling techniques, as well as rules and regulations. We then held a riverside session in which mentors taught students how to dissect the water and get hooked up with the elusive steelhead. As always, we have encouraged parents to participate. This helps to facilitate and enhance the interest of kids that want to participate in this rewarding endevour! In 2018, thanks to Keith Behn, the LSSA looks to provide an additional program, Fly Fishing for Steelhead, that would be offered to graduates of the Youth Mentoring. Thank you Keith for taking lead on making this a possibility. We all owe Gary Siverson a great thanks for continuing to do an excellent job scheduling and facilitating the Youth Mentoring Program.

In 2017, the LSSA wrapped up the in-stream work on Phase II of our grant and could not be happier with the result! Even during flood flows, the channel upheld and diverted flow to the middle of the river, drastically reducing erosion and the negative impacts of eroding clay banks. Additionally, we aligned with Zeitgeist as we pursued funds for Phase III of our grant. After a lot of hard work, we were awarded funds to pursue this grant and regained traction to rehabilitate our Knife River

watershed and, subsequently, our naturalized steelhead. In this phase, Zeitgeist will be providing much appreciated administrative help. This move should set our organization up for future rehabilitation successes for years to come!

In March of 2017, we participated in the Great Waters Fly Fishing Expo in the Twin Cities. This has been a great event for our association and always generates a lot of interest in the LSSA. Scott Thorpe has continued to do an excellent job representing us at the show and getting our mission and vision out there. If you haven't fly fished for steelhead and have been interested in doing so, this is a great venue to get you a head start in the game!

In April, we hosted our first ever annual banquet at the Clearwater Grille, just northeast of Duluth. With another record turnout, we realized the need for additional space and the Clearwater delivered! It was a phenomenal venue. Kevin Bovee, yet again, did a superb job organizing the whole event and putting together another great prize package! The food, the drinks, and the camaraderie were second to none! I urge you, especially if you have missed this event in recent years, to pay close attention to our news and put this event on your calendar, simply fantastic! Thanks again to Kevin Bovee for organizing this event.

In June of 2017, the LSSA held our annual planking party at Brighton Beach. This was the third year at the new location and it has been a great location at that! #### South Shore Railroad Grade

The LSSA recently donated \$2000 to the Brule River Sportsmen's Club to assist in their initiative to raise funds to resolve a failing concrete culvert over Nebegamon Creek, a major tributary to the Bois Brule River. The culvert is part of an abandoned railroad grade of the defunct South Shore Railroad, which stopped operations in the late 1800s. The beginning of the collapse first surfaced in 1992 and some remedial work was done thereafter. In the fall of 2009, a local resident noted that the downstream concrete wing- walls had further collapsed into the stream, backing up water for a considerable distance upstream. He contacted WI DNR fisheries staff and a biologist visited the site. Fisheries staff photographed the scene and reported this issue to the local DNR water regulatory specialist. Nothing further

has been resolved. The holdup, according to the local DNR staff, had been determining the responsible party or landowner of the portion of the abandoned grade at the Nebagamon Creek crossing.

Action needs to be taken as soon as possible before the following expected scenario occurs: The culvert collapses and streamflow potentially becomes blocked completely. Nebagamon Creek, which drains about 28 square miles and carries on average about 16 cubic feet of water second, backs up very quickly. The grade then acts as a dam and fills the entire valley upstream to a point where the grade either collapses or is eventually overtopped and washed away.

The extent of the threat to the Bois Brule depends on how much water is impounded and how quickly that impounded water erodes away the grade. A catastrophic failure would create a flash flood that would quickly erode a larger stream channel, washing away the sandy stream banks. An even larger concern is that the huge volume of sand would create an extremely large sand slug. This sand slug would be a major threat to the trout fishery of the Brule as it slowly creeps downstream. It might take decades to move down the river before it reaches Lake Superior. It would fill pools, cause channel widening and sequentially bury trout habitat and destroy spawning areas.

The Brule Sportsmen's Club moved to seek immediate attention to this Bois Brule River fishery threat and has begun a fundraising effort, approaching local conservation groups and individuals. Join the LSSA in donating. Donations can be made to BRSC PO Box 100, Brule, WI. 54820.

Spend time on the Bois Brule, or the bigger North Shore rivers like the Baptism and you will become increasingly aware of the number of anglers casting with double handed rods and swinging streamer style patterns. Twenty years ago, nearly every angler fished with tackle in a style I will call drift fishing, i.e. a spinning rod or fly rod and reel loaded with monofilament and a snelled yarn fly or spawn sack on the business end. While guiding this last fall on the Brule, I was surprised that one in three anglers I encountered were swinging with two handed switch rods. The remaining two thirds were either conventional drift style anglers, center pinners or fishing with a floating fly line and a strike indicator.

Before my fall Brule stint, I had just returned from a week on the Margaree River in Nova Scotia, fly fishing for Atlantic salmon, where the tradition of swinging a wet fly, using a downstream and across cast is deeply rooted and universally practiced. In fact, Nova Scotia fishing regulations forbid the use of split shot or even weighted flies and the Margaree Salmon Association frowns upon the use of

sink tips. Single barbless hooks are the law, all salmon are released. Fly fishing with a nymph, an egg pattern and a strike indicator as I do here would have landed me in jail. Only one technique approved, and very strong behavioral etiquette has developed, common manv Atlantic salmon fisheries and many West Coast steelhead rivers too.

These customs evolved as a response to the available tackle of the



time, the nature of the rivers fished and the taking preferences of the fish themselves. In Minnesota, for example, most of our rivers are high gradient spate rivers. With bed rock and shingle bottoms, these rivers feature extremely fast current that surges thru pools which are often short and varied in depth. Old time North Shore steelheaders quickly discovered the shortcomings of conventional wet fly trout fishing techniques. By the time a wet fly was deep enough, it had already swung out the end of the pocket. Our drift style techniques of using a big sinker, and monofilament line is perfect for getting deep and doing so quickly. Our spring run fish are on the bottom and you need to put the fly right in front of them. Our fishing etiquette is more of what I call "grizzly bear" behavior. Stake out your pool, first come first serve, plant your feet, pound away and growl at anyone who comes close.

Contrast this with swinging for Atlantics on the Margaree.

It's still first come first serve, but every pool has a bench or at least a log up near the head for anglers to sit upon. Many of the benches feature plaques that are inscribed with dedications to deceased anglers. The first angler to fish a run steps in at the head and begins swinging their way down river, taking two steps between casts. You can fish as slow or fast as you want if you are alone. As other anglers arrive at the pool, they take a seat, and wait their turn in the rotation. You keep working your way thru the pool - cast, two steps, cast, two steps. As soon as there is twenty some yards of room at the head of the run, the next angler steps in. When you finish working thru the run, you join the gang on the end of the bench. If you hook and land a fish, you start over again at the end of the bench and hopefully share a nip from your flask! Everybody gets to fish eventually, fish thru the run as many times as they want, no matter how coveted the run. Sitting on the bench inevitably leads to conversation. "Where are you from? Any luck recently? What flies are working?" Everybody is swapping flies, and the general mood

is friendly and non-competitive. It can be a bit intimidating having your spey casting scrutinized by the watching gallery, but that's the only downside. It works well on a popular river because all the anglers are fishing the same way.


As all these different techniques take hold in our rivers, we need to consider the impact to our etiquette. Floating fly line and strike indicator fishing works best starting toward the tail of a pool and working up river, while swinging anglers must start at the top of the run and work down. Center pinners can fish the entire run from any one spot, while drift style fishers can work either up or down a pool. In either case, there is plenty of opportunity to get in each other's way. Some pools are nearly impossible to fish with certain techniques. It seems a good run for swinging a fly is hard to come by, especially on the north shore. It's a technique that suitable for a longer run. Several times these past few years I have been fishing down from the head of a long run, and had another angler jump in what they assumed was a reasonable distance downstream of me, not even realizing that my fly is ten yards below me and that I am stepping my way down to them. In minutes, I am about to snag their waders. On the other hand, some rivers are always crowded, and it isn't fair to expect room for the swung technique. I am hoping some of the longer, more swing suitable runs will develop a steelhead sub-culture etiquette like the traditional Atlantic salmon experience I enjoyed I on the Margaree. With this in mind, I resolve to fish through a pool quickly and allow other anglers a chance. This will probably increase my hook-ups too, as I will cover more water and find the aggressive biters. I will try to be aware of how other anglers are fishing and I will try to coordinate my approach. Finally, I will always ask before I join someone in a pool, it's just polite.

- 1. Gambling Report: All required forms were sent for review, discussion and approval. Motion by Behn to accept the report as presented. Motion seconded by Pitan and motion passed. Bingo progressive getting up to the maximum of \$ 1199.
- 2. Treasurer's Report: All commented on great it is to have the treasurer on hand for meetings. We are getting spoiled. Treasury in good shape.
- 3. Mentoring-2018: LSSA approved the event again for 2018 previously and Siverson then ordered the rods through MGS. - 1. Gambling Report: All monthly forms were sent out for review, discussion and approval. Motion by Siverson to accept the report as presented. Motion seconded by Wistrom and motion passed. Also-later in the meeting there was a conversation concerning a culvert issue on the Brule River system that needed addressing. Motion by Bovee to pledge \$ 2000.00 for this project. Motion seconded by Behn and motion passed. See below for discussion.
- 2. Treasurer's Report: Treasury in good shape. Several bills paid-Planking Party permit cost, down payment to Clearwater Grille for the 2018 banquet and Greg Kunst Gravel to wrap up Knife River project.
- 3. Angler Update: Advertising push has commenced. Any ideas for contacts please get in touch with K. Bovee.
- 4. MN DNR LSMP Position Statement: Lake Superior Area looking for input from area groups on how they feel concerning several major questions and what each group would propose. Topic of conversation on the genetic concerns over the Kamloops/steelhead interbreeding. This conversation was extremely complex and quite extended. We have put the questions from DNR and the LSSA's response on the website:

- 5. WI LSMP: Next meeting is scheduled for November 15 down in Ashland. Pitan and Behn have been attending to represent the club. More input sought from the board for upcoming discussions.
- 6. Newsletter Update: Sounds like Jason Kopp may be interested in taking on the editorship of the newsletter. S. Thorpe to get out the last newsletter for 2017 by mid December.
- 7. Grant Update: Phase IIconstruction is 100% complete. LSSA will continue to monitor the sites annually and after any large runoff events. Phase III-Zeitgeist/LSSA has made the list to date. Last meeting for the council to finalize the list to be included to the 2018 legislature is set for December 12. Bovee & Siverson to attend. Finally-LSSA decided to pursue a Lake Superior Coastal Project grant. This is a federal grant through NOAA and monitored by the MN DNR. January 2018 is the decision time for this grant.
- 8. Advanced Mentoring: This is a brand new project that Pitan and Behn are spearheading. It will be a mentoring project centered specifically at fly-fishing for steelhead. Past members of the mentoring project will be contacted to see if they have interest in the fly fishing side. We can get spare reel spools that match the existing reels the kids already have and load them with backing and fly line. A minimum of six kids with a maximum of ten hoped for. Watch for future developments.
- 9. Old/New/Other: Discussion on the culver issue on the Brule River. BRSC President, Dennis Pratt, has brought forward this issue and the preferred solution is quite expensive. The LSSA made the motion to support this project-see Gambling Report.




